I understand that I may be handling animals while providing my volunteer services for TiggerTown, Inc. and therefore there exists a risk for personal injury. On behalf of myself, my peers, personal representatives, and executor, I release, discharge, indemnify, and hold harmless TiggerTown INC., its agents, servants, and employees from any and all claims, causes of action, demands of any nature, or causes connected with my volunteer contract. This could include any costs, attorney's fees, and court costs incurred by TiggerTown in connection with my volunteer services based on damages or injuries which I may incur in any way while volunteering. Such damages are not limited to, but may include animal bites, accidents, injuries, and personal property damage.

I agree to release, discharge, indemnify, and hold TiggerTown, Inc. harmless for all damage to my personal property while providing my services on a voluntary basis to TiggerTown, Inc. its agents, servants, and employees. I fully understand and agree to assume all risks involved in all duties that I perform for TiggerTown, Inc. in my volunteer capacity. Such duties might include, but are not limited to, animal handling, custodial work, kennel staff assistance and other volunteer duties.

I understand that my time with TiggerTown, Inc. may include various activities that may possibly be hazardous to me and I hereby expressly and specifically assume the risk of injury or harm in these activities and release TiggerTown, Inc. from all liability for injury, illness, death, or property damage resulting from the activities of my time with TiggerTown, Inc.

I understand that public relations are an important aspect of volunteer work at TiggerTown I, therefore, agree on behalf of myself, my peers, personal representatives, and executors, to allow TiggerTown, Inc. and its agents to use any photographs, video, or film taken of me for use in public relations efforts. TiggerTown, Inc. will use all reasonable efforts to notify me, but notification is not required for the photographs, video, or film to be used for public relations purposes.

I agree to familiarize myself with TiggerTown, Inc. policies and procedures and will fully comply with both the letter and spirit of these policies and procedures. I understand the policies and procedures are subject to change.

I expressly agree that this Waiver is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee in the United States of America, and that this Waiver shall be governed by and interpreted in accordance with the laws of the State of Tennessee. I agree that in the event that any clause or provision of this Waiver shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to enforceable.
