\_\_\_\_\_\_ I agree that this pup will not be strictly and exclusively an <u>OUTDOOR</u> family pet, will not be on a chain, and will not be used in any way detrimental to him/her; such as for medical research, or in any way that could cause hardship or pain to the pup.

\_ I agree that this pup will never have a tail docking or ear tipping procedure.

\_\_\_\_\_ I agree that this pup will remain in my custody and possession. If I cannot keep this pup for any reason, it must be returned to TiggerTown, Inc., from whom it was adopted.

\_\_\_\_\_ I understand that to the best of your knowledge, this pup is in good health. I agree that I have been informed of this pup's current condition and previous illnesses if any existed and I am willing to continue the current treatment or future treatments that will maintain this pup's health.

\_\_\_\_\_\_ I agree that TiggerTown, Inc. cannot be responsible for the future physical condition of, temperament of, or damages (to property or others - including animals and people) caused by this pup. TiggerTown, Inc. will not refund any costs that occur after the date of adoption; such as veterinary expenses, license fees, or the cost of pet supplies. I agree that I am hereby responsible for any and all costs incurred by this pup from this day forward and agree to hold harmless TiggerTown, Inc., Board of Directors, Staff and Volunteers for any damage to person or property that may result from owning this cat.

\_ I agree that the adoption fee is non-refundable and will be considered a donation if the pup is returned to TiggerTown, Inc.

\_\_\_\_\_ I am aware that this pup may be in the custody of TiggerTown, Inc. due to cruelty, neglect, injury or abandonment, and that it may take several weeks-to-months for him/her to adjust to their new home.

\_\_\_\_\_ I understand that failure to perform the foregoing agreement will constitute a breach of contract. In the event of any such breach of contract, I authorize the original rescuer to reclaim possession of the adopted pup.
